

TAX LEVY ORDINANCE

MAINE TOWNSHIP

ORDINANCE No. 2019-5

An ordinance levying taxes for all town purposes for Maine Township, Cook County, Illinois, for the tax year 2019, collectable in 2020.

BE IT ORDAINED by the Board of Trustees of Maine Township, Cook County, Illinois, as follows:

SECTION 1: That the sum of three million nine hundred and ninety nine thousand seven hundred and ninety three (\$3,999,793) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as GENERAL TOWN FUND AND GENERAL ASSISTANCE FUND.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.







General Town Fund and General Assistance Tax Levy




