







Section 2: That there is hereby appropriated for Road District purposes:

Section 3: That each total is divided among the several objects and purposes specified and in particular amounts stated for each fund respectively in Section 1 constituting the total appropriations in the amount of Two million, four hundred fifty-five thousand, nine hundred five dollars (\$2,455,905.00) for the fiscal year March 1, 2015 to February 29, 2016 and that Section 2 shall be and is the annual Appropriation Ordinance of the Road District, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

Section 4: A certified copy of the Budget and Appropriation Ordinance must be filed with the Cook County Clerk within 30 days after adoption.


